
MVRPC's Rideshare Program

The Miami Valley Regional Planning Commission sponsors the local **RIDESHARE** Program which is available for **FREE** to anyone who lives, works or attends college in Montgomery, Greene, Miami, Preble, Darke and Clinton Counties. Register for the Rideshare Program and explore smarter ways to commute like ride matching to form a carpool or bikepool, transit and bike routes to match your trip or form a vanpool for longer commutes.

How to Register:

Explore Commute Options:



Carpooling

A carpool is an arrangement between 2 or more people to make a regular journey in a single vehicle. This option is a great way to save money by sharing costs and to reduce air pollution and traffic congestion by reducing the number of vehicles on the road.



Vanpooling

If you have a long commute, you and larger group of people may be interested in renting a van on a monthly basis. The monthly vehicle rental rate and other expenses can be split evenly between passengers.



Biking

Form a bikepool with others to bike together. Explore bike route options in the area. Commuting by bike saves you money and improves your health.



Take Transit

Explore transit routes. Taking the bus can reduce commute costs and enjoy a relaxing commute by letting someone else drive.

Guaranteed Ride Home

For those who are registered for the Rideshare Program at GohioCommute.com and participating in a carpool, vanpool or bike commuting, you are eligible for the Guaranteed Ride Home Program (GRH). This program reimburses registered users 80% of the cost of a ride service to your home address on file or to the site of an emergency when needed. This reimbursement is available up to 4 times in a 12 month period.

You can use GRH if you are registered on GohioCommute.com and used a sustainable transportation option listed above and: You or a member of your family becomes ill; You unexpectedly must work past your normal quitting time or Your carpool/vanpool driver has to leave early.

Applicants and participants may or may not possess a valid driver license. All applicants and participants use this rideshare service at their own risk.
