The Miami Valley Regional Planning Commission Board of Directors met on December 7, 2023 at 9:00 a.m. at Dayton Realtors, 1515 S. Main Street, Dayton, OH 45409. All members and news media were notified of the meeting pursuant to the Sunshine Law.

I. **INTRODUCTIONS**

Vice-Chairperson Lommatzsch called the meeting to order at 9:05 a.m. Self-introductions were made and a quorum was confirmed for the Miami Valley Regional Planning Commission's Board of Directors meeting. The Pledge of Allegiance was recited.

II. **APPROVAL OF NOVEMBER 2. 2023 MEETING MINUTES**

Mr. Klepacz made a motion to approve the minutes from the November 2, 2023 Board meeting. Mr. Housh seconded the motion. The motion passed unanimously.

III. PUBLIC COMMENT PERIOD ON ACTION ITEMS

None

IV. MPO (METROPOLITAN PLANNING ORGANIZATION) ACTION ITEMS

A. Resolution 23-038: Supporting the Infrastructure Investment and Jobs Act Safety Performance Management Targets

Ms. Ramirez presented information regarding the Infrastructure Investment and Jobs Act (IIJA) Safety Performance Management Targets. She explained that after a state DOT adopts targets for a particular rule, MPO's have 180 days from the date targets are established by a state to adopt their own targets or support the state's. MVRPC has decided to support the State's targets for the safety measures. Ms. Ramirez then summarized the safety measures and targets including the impact that a 2% reduction for CY 2024 has on target crashes. The CY 2023 target maintains the rate adopted in CY 2023 due to Governor DeWine's focus on safety and associated increases in funding. Lastly, Ms. Ramirez stated that staff and the Technical Advisory Committee recommend approval of the resolution supporting the IIJA Safety Performance Management Targets to the Board of Directors.

Mr. Joseph made a motion to adopt resolution 23-038 supporting the Infrastructure Investment and Jobs Act Safety Performance Management Targets. Mr. Stroud seconded the motion. The motion passed unanimously.

B. Resolution 23-039: Recommended Adoption of Amendment #4 to MVRPC's SFY2024-SFY2027 Transportation Improvement Program

Mr. Arnold referred to the 4th amendment to the SFY 2024-2027 TIP and the numerous project changes made by MVRPC and ODOT. He referred to the packet showing the tables broken down by county as well as the statewide line item project tables. Mr. Arnold mentioned staff and the Technical Advisory Committee recommend adopting Amendment #3 to the SFY 2024-SFY 2027 Transportation Improvement Program.

Ms. Wallace made a motion to adopt Amendment #4 to the SFY 2024-SFY 2027 Transportation Improvement Program. Mr. Berry seconded the motion. The motion passed unanimously.

V. INFORMATION ITEMS

A. Proposed New Projects Requesting MVRPC's STP, TA, and CR Funds

Mr. Arnold presented information on the proposed new projects received as part of MVRPC's solicitation for regionally controlled funding under the Surface Transportation Program (STP), Transportation Alternatives (TA), and Carbon Reduction (CR) programs. He then referred to the table outlining CY2023 Summary of STP applications. Mr. Arnold then stated that a public involvement meeting to present the proposed new projects was held on November 9, 2023 and no comments were received during the public comment period.

Lastly, Mr. Arnold explained that the next step in the process is to evaluate each proposed project based on the criteria established in MVRPC's suballocated funding policies and procedures. After each project is ranked, a final list of recommended projects will be reviewed by the TAC in February and then forwarded to the Board for final approval in March.

B. Going Places Implementation Tools Progress Update

Mr. Kim presented a progress update regarding the <u>Going Places</u> Implementation Tool A, Regional Geographic Information System. He first shared information on the data available for the Miami Valley Region and shared images of the following websites: <u>Miami Valley Geo-Spark</u>, <u>US Census Data</u>, and <u>MVRPC's D-Hive</u>. Next, Mr. Kim provided information on how MVRPC's GIS staff can be a wonderful resource for members along with maps, applications and Dashboards they create and the classes and GIS trainings they provide. Lastly Mr. Kim presented examples of some of the GIS Presentations and Awards received such as the most recent 2023 URISA Exemplary Systems in Government (ESIG) Award. Mr. Kim then opened the floor for questions. Mr. Martin thanked Mr. Kim and his department for their work on the 2019 Tornado Recovery Monitoring System and also thanked the TAC for submitting their disaster recovery data needed to create the monitoring system.

C. Drive Electric Dayton Update

Mr. Celek thanked MVRPC and the Board of Directors for the opportunity to present information about <u>Drive Electric Dayton</u> (DED). He first provided an overview on the region's history related to electric vehicles (EVs) over the years. He then shared some of the most <u>recent events</u> that Drive Electric Dayton has hosted or attended. Next, Mr. Celek discussed the importance of community partnerships and recognized a few of their current partners. Next, Mr. Celek explained the importance of equity as it relates to EVs and referred to a map showing EV Equity in Ohio. Lastly, Mr. Celek provided information on EV charging and asked the TAC to think about updates to codes as it relates to wringing for EV charging. Mr. Celek then opened to floor for questions and discussed <u>EV home charging</u>.

Mr. Martin thanked Drive Electric Dayton for their partnership and shared that Drive Electric Dayton had inquired about becoming a member of MVRPC. He then asked the Board of Directors for a motion to approve as a non-government member.

Mr. Berry made a motion to induct Drive Electric Dayton as a non-governmental member. Mr. Joseph seconded the motion. The motion passed unanimously.

VI. EXECUTIVE DIRECTOR'S REPORT

A. Executive Director's Update

Mr. Martin and Vice-Chairperson Lommatzsch thanked the departing Board Members for their service to their communities and awarded them with certificates on behalf of MVRPC.

Subject: FY2025 Transportation and Government Services Priority Development and

Advocacy Committee (PDAC) Projects

The Miami Valley Regional Planning Commission is working with other organizations throughout the Miami Valley to identify projects that may be eligible for funding. This group, the Dayton Region Priority Development and Advocacy Committee, has developed a process for soliciting projects for consideration of funding through the legislative process. Through a committee decision, the top projects are forwarded on to elected officials for deliberation.

MVRPC is the lead agency for Transportation projects, which include any surface, air, rail, transit, and pedestrian transportation-related projects. Seven FY2025 PDAC Transportation project applications, requesting \$33 million, were received by the deadline of November 3, 2023 (see attached Exhibit 2).

MVRPC is also the lead agency for Government Services projects, which include any emergency services, criminal justice, first responders, community and neighborhood infrastructure and K-12 education-related projects. Sixteen FY2025 PDAC Government Services project applications, requesting \$143.8 million, were received by the deadline of November 3, 2023 (see attached Exhibit 3).

The Transportation and Government Services projects were evaluated by a review panel on January 4, 2024. The Review Panel then categorized the projects into Priority, Recommended, and Reviewed. The MVRPC Review Panel is forwarding seven Transportation "Traditional" (Roadway)/"Non-Traditional" (Bikeway) projects and sixteen Government Services projects for submittal to the Dayton Region Priority Development and Advocacy Committee in categorized order as shown in Exhibit 1. A resolution endorsing these recommendations is attached for your consideration.

The list of projects is now being sent to the MVRPC Board structure for final review and adoption and submittal to the Dayton Region Priority Development and Advocacy Committee.



It is my pleasure to announce the MVRPC member organizations that have applied to receive a Second Year Age-Friendly Responsive Grant from the DMH-Dayton Fund at The Dayton Foundation. The Second Year Age-Friendly Community Responsive Grants will support communities advancing into Phase 2 of the AARP Livable, Age-Friendly Communities multi-year planning effort, which focused on developing action plans and moving towards implementation. A summary of applicants' project proposal is as follow:

Community: Centerville

Project Description: The City of Centerville takes pride in hosting vibrant community events that bring residents together for social engagement and shared experiences. However, some members of our community face mobility challenges that hinder their ability to attend and fully participate in these events. To address this issue and foster inclusivity, we propose the acquisition of a golf cart to provide accessible transportation for individuals with mobility difficulties during Centerville events. The golf cart would provide: enhanced accessibility, inclusive community participation, Age-Friendly activism.

Amount Requested:

Total Project Budget: \$16,000

Community: Harrison Township

Project Description: Sinclair Park was heavily damaged in the 2019 tornados – recovery has been slow and in turn, the park has been heavily underutilized. HT intends to hire Human Nature, Inc., a consultant specializing in Park Planning, to complete a 6-month master plan for Sinclair Park. The master plan process will include assembling a steering committee and hosting 3 public meetings to incorporate community input.

Amount Requested: \$10,000 Total Project Budget: \$49,500

YS proposes to improve its walkability and thus resident's health and well-being through two related projects: improving the walkability of sidewalks and adding "Happy to Chat" benches along way points that will provide stopping places for older adults and conversation points for all ages.

Amount Requested: \$7,530 Total Project Budget: \$10,930

The following chart outlines the recommendation to fund all 4 applicants at the maximum funding amount for the grant, for a total of \$40,000. Please note the DMH-Dayton Fund at The Dayton Foundation allotted \$75,000 for the Second Year Age-Friendly Communities Responsive Grant Program. Therefore, it is recommended that the remaining \$35,000 be used to support new communities joining the AARP Livable, Age-Friendly Communities. It is also recommended that the application process for the Age-Friendly Grants move to a rolling basis, allowing communities more flexibility to join. Therefore, the ISC will potentially review applications from new communities at quarterly meetings.

Every ten years after the Census Urbanized Area is defined, the Federal-Aid Urbanized Area Boundaries must be updated. This is the first step in updating the functional classification for all roads contained within the new Urbanized Area Boundary.


Enclosed is one map highlighting the proposed 2020 Federal-Aid Urbanized Area Boundary as well as showing the 2010 Federal-Aid Urbanized Area Boundary. The boundary is being extended in various locations to reflect the 2010 Census designated boundary as well as additional extensions to smooth out irregularities, maintain administrative continuity of peripheral routes, and encompass fringe areas having residential, commercial, industrial, and/or national significance. At a minimum, the Dayton Urbanized Area Boundary fully encompasses the 2020 Census Urbanized Area, the incorporated areas of all jurisdictions that are partially or wholly within the 2020 Census Urbanized Area, and the entire 2010 Urbanized Area Boundary.

A resolution endorsing the Proposed 2020 Federal-Aid Urbanized Area Boundary Update is attached for your review and consideration. The MVRPC staff recommends your approval of the Proposed 2020 Federal-Aid Urbanized Area Boundary.

- Ohio Auditor of State filed the final report to the clearinghouse Jan 30.
- No fraud
- No missing funds
- Followed all Federal and other laws on expenditures.
- However some errors were highlighted.



FY22 Audit Schedule of Findings

Finding #2202-001: Material Weakness - Financial Reporting

Due to lack of controls over the preparation of the financial statements, MVRPC's annual financial report for fiscal year 2022 contained the following errors which were material and adjusted, as agreed upon by management, on the basic financial statements:

- Details inaccurate reporting of many revenue and expenditure categories.
- MVRPC Staff have worked with Perry and Associates and have made the requested ledger changes, which Auditor acknowledged.
- FUTURE: Staff is working closely with Perry to ensure financial statements follow the Auditor's recommendations.



FY22 Audit Management Letter

Non Compliance Findings

- 1. The Commission did not file the 2022 Annual Financial Report with the Auditor of State's Office until May 10, 2023 which was not within the designated 150 days following the fiscal year end due date of November 28, 2022.
- FY22 Delays were caused by staff turnover just prior to the filing date.
- The Commission's Public Records Policy was not included in the Personnel Policies and Employee Handbook. This could result in employees not being aware of the proper handling of records requests in accordance with Ohio law
- The Policy has been added to the Employee Handbook. HR is working to distribute to existing employees and will collect signed acknowledgements

Recomendation

- Financial Misstatement resulting in overstated cash balance at the Fiscal Agent, Montgomery County. Staff should establish and implement processes to veryify accuracy of ammounts reported.
- This is related to staff inexperience related to timing of the closing of the year end ledger.

- MVRPC supplied the auditors with an official response which was included in the Audit.
- MVRPC will implement changes to avoid sloppy accounting.
- 2. MVRPC will consult with peer agencies regarding internal processes as means to augment inexperienced staff.
- 3. MVRPC staff will utilize Ohio training opportunities via AoS and ODOT as they become available.
- MVRPC will support staff professional development where appropriate in professional associations such as GFOA.

December 12, 2023

On behalf of the MVRPC Board of Directors, the Executive Director and current Agency Operations staff of MVRPC we acknowledge the four issues identified by the state of Ohio in this FY 2022 audit. The financial statements inaccurately describe the agency's FY 2022 financial position. The primary reason for this was the lack of financial knowledge and experience in the department following the retirement of longstanding staff members during FY 2020 and 2021. The replacement staff proved to be less competent and less professional than required for these positions, which ultimately led to the termination of the former director during FY 2022 and the eventual departure of her support staff from MVRPC during FY 2023.

Anticipating problems with our basic financial processes and reporting, we have hired new staff and expanded the Agency Operations finance section with an eye toward more professional accounting due diligence and consistency. Our second accounting professional starts work at MVRPC on December 14, 2023. We will learn from this audit process and we hope that future audits will have fewer findings.

Moving forward, as discussed among E.D. Martin with Director Lucas:

- we will implement the needed changes identified in this audit. While the findings generally reflect sloppy accounting, we are very grateful there are no findings of fraud and no indications of any missing agency funds.
- 2) We will consult with peer regional councils to review and incorporate their procedures where better to ultimately lead to improved processes at MVRPC to ensure that our financial records are better organized for staff and auditors to find what they're looking for.
- 3) We will utilize state of Ohio training opportunities through Local Transportation Assistance Programs (LTAP, accounting industry training, and other sources) with a focus on local Ohio trainings for regional councils or similar entities.
- 4) We will continue to support staff professional development and expand training opportunities through professional finance associations such as Government Finance Officers Association (GFOA), where appropriate.

We will learn from this experience and hope for better results in the FY 2023 summary report of the agency financials. Unfortunately, due to the lateness of the FY 2022 audit, FY 2023 financials have been closed out. Ultimately, we are striving to incorporate much improved accounting practices for a much better FY 2024 audit and increased agency financial capacity among the staff.



Neighborhood	Vibrant neighborhoods include residential, retail and open spaces that are well connected and meet the needs of all in the surrounding community.
Safety & Justice	Public health, safety, general welfare, and justice are fundamental needs. They are not luxuries afforded to a few. They must be protected and upheld for all individuals.
Technology & Connectivity	Expansion of access to technology, connectivity and the intentional dissemination of information through a wide variety of traditional and digital means to ensure all members of the community are informed of matters that impact them.
Transportation	Driving a car shouldn't be the only way to get around. Public transit, coordinated mobility and human service transportation systems, integrated freight and logistics systems, walkability, and bike-friendliness contribute to livable, equitable and lively communities for all.


PCAP GHG Inventory




Emissions by sector




Emissions by sub-sector



Emissions by greenhouse gases




Overall GHG emissions - CO₂



Overall GHG emissions - CH_4




Overall GHG emissions - N_2O






An Informative Session on Progress in Securing Funding for Passenger Rail Service

All Aboard Ohio (AAO) recently hosted an informative session on January 11, 2024 at the Dayton Metro Library. The event was aimed at providing an update on the significant strides made in the Federal Railroad Administration (FRA) process, a crucial step in securing funding for passenger rail service in Ohio.

The session was attended by a diverse group of stakeholders, including community leaders, transportation enthusiasts, and concerned citizens. During the event, AAO shared its progress in navigating the FRA process, demonstrating confidence in its ability to move forward successfully.



One of the key highlights of the event was the unveiling of future plans and an in-depth discussion of the next steps in the FRA process.
