The Miami Valley Regional Planning Commission hosted the Regional Equity Initiative Sub-Committee meeting on August 27, 2024 at 11:00 a.m. at the MVRPC Office and via Zoom Video Conference.

I. WELCOME & INTRODUCTIONS

Chairperson Rap Hankins called the meeting to order at 11:00 a.m. Self-introductions were made.

II. PROGRAM MANAGER DOMAIN UPDATES

Regarding the Engagement Domain:

Fabrice Juin reported on recent MVRPC sponsorships and partnerships:

- The 2024 Annual Breakfast Meeting organized by the African American Community Fund (AACF) of The Dayton Foundation, which manages over 180 funds supporting education, culture, civic life, and human services.
- Sponsored the 17th Annual Signature Ride for Charity, hosted by the Major Taylor Cycling Club Dayton, honoring the legacy of Major Taylor, a pioneering African American cyclist.

- Presented to the Gen D Ignite Cohort about digital equity in the Miami Valley. This group of young professionals is creating a directory of digital services to improve access and equity in the region.
- Presented during the Dayton Regional Green Sustainability Luncheon on environmental justice, social equity, and sustainability.

Regarding the Health & Environment Domain:

The EJCPS Cooperative Agreement was discussed, which funds organizations addressing environmental and public health issues. Mr. Juin noted the goal of the agreement is to foster collaboration between local businesses, government, healthcare providers, and community stakeholders to find solutions. This initiative will establish the Miami Valley Environmental Justice Partnership, offering micro-grants and grant-writing support, with ABLE leading the effort. However, due to updates in EPA guidelines, the project launch has been delayed to January 2025.

Fabrice Juin discussed the resolutions for the Community Problem-Solving Grant (CPRG) and EJCPS. It was decided that it's too early for the Board to formally commit, especially as EJCPS hasn't launched yet. The Executive Director suggested sending a note of congratulations to the project sponsors. The Board looks forward to offering feedback as the projects progress.

An update on the Community Change Grants Program, which focuses on environmental and climate action in disadvantaged communities, was received. Track I will support climate and pollution reduction projects, while Track II will empower communities to engage in governmental processes for environmental justice.

Regarding the Housing Domain:

Mr. Juin explained in the U.S., the right to counsel is guaranteed in criminal cases but not in civil cases like eviction proceedings which leaves low-income tenants at a disadvantage. Without legal representation, tenants often face preventable evictions with serious consequences, such as loss of housing, health issues, and disruptions to family and employment stability. The Access to Counsel Pilot Project aims to fill this gap by providing legal representation to tenants facing eviction.

Led by Learn to Earn Dayton and ABLE, the project will launch in northwest Dayton's Omega CDC Hope Zone, an area with a high number of tenants at risk. The hope is this pilot project will demonstrate the positive impact of legal counsel for tenants and advocate for statewide Access to Counsel legislation.

Regarding the Technology & Connectivity Domain:

The Affordable Connectivity Program (ACP) which provided internet service discounts to low-income households ended on June 1, 2024. The ACP served over 23 million households across the U.S. with 15% of enrollees in rural areas and about half of enrolled individuals over 50. Ohio ranked second in ACP enrollment, with 57.6% of eligible households participating.

The Digital Equity Competitive Grant Program aims to promote digital inclusion with grants of \$5 million to \$12 million for community projects. United Way of the Greater Dayton Area is considering applying for a grant.

III. FY25 PROJECT FOCUS: MIAMI VALLEY ENVIRONMENTAL JUSTICE PARNTERSHIP

Mr. Juin presented on FY25, the REI Subcommittee's priority will be formalizing the Miami Valley Environmental Justice Partnership. This initiative will form a structured, intentional approach to addressing environmental justice across the Miami Valley.

Moving toward formalizing the Miami Valley Environmental Justice Partnership, there are some important questions to consider:

- Who is missing at this stage? Are there communities or stakeholders that haven't been fully engaged?
- What would formalization look like? How should this effort be structured so that it has lasting impact and effectiveness?
- Should we align our efforts project by project, or should we be thinking about this in a broader, regional sense?
- What is the vision of the REI Subcommittee? What are the key do's and don'ts as this partnership is built?
- Finally, are there any examples that might guide efforts in formalizing this partnership?

IV. AGENCY DATA MAPPING & METRICS

Mr. Juin reminded the REI that MVRPC is a Census Affiliate Organization, which means MVRPC assists with various programs from the U.S. Census Bureau and keep Census data for the region. Data is available going back to 1950, with the most recent updates available. The Miami Valley Data Commons offers a wealth of data on a variety of topics for the counties of Darke, Greene, Miami, Montgomery, Preble, and Warren. The topics covered align with the information found in the Regional Profile, so it's a great resource for local insights.

V. ACTION ITEMS, FOLLOW-UP, & NEXT MEETING
